Note: Paper-wise improvement is permissible in the next immediate examination only subject to the condition that the candidate has secured $SGPA \leq 7$ with course wise $GPA \leq 7$. However, the improvement marks shall not be considered for award of Ranks or Certificates.

Instructions to the Students:

- The students shall pay the examination fee online in the ERP portal only.
- All the students are informed to clear all the fee dues (if any) before the payment of examination fee.
- The login for examination fee payment will be closed on the last date i.e., 09.08.2024 at 11.00 pm without late fee and on 12.08.2024 at 11.00 pm with late fee of Rs. 300/-
- Students are advised to download the fee receipt after successful payment of examination fee from the portal without fail and submit the same in the Examination Cell for inclusion of their name in the Nominal Rolls.
- Students shall enclose xerox copy of I Semester Marks Memo along with fee receipt.
- Students can report the problems or issues if any encountered during the registration/fee payment process, to the Controller of Examinations immediately.
- Hall tickets shall be issued only to the eligible candidates who fulfill all the academic and other requirements. Mere payment of examination fee does not ensure eligibility for appearing the examinations.
- Students shall be responsible for the mistakes/omissions if any while filling the online information. Rectification of errors shall be permitted on payment of Rs. 100/- for each

error.

- Students shall note that Fee paid once cannot be refunded or adjusted for any future examinations.
- Students are advised to ensure payment of fee before the due date to avoid unnecessary penalties.
